So sorry, I forgot to include the summary of clauses – copied below for you!

Clause 1: addresses the 'other income' data and provides that other income from HMRC be included as

part of the standard calculation for child maintenance payments.

==> The draft arrears strategy includes steps towards this by saying they will ask for this data from

HMRC if there is an indication that this is relevant when a receiving parent makes their

application. But the strategy stops short of including this data as part of the standard calculation.

Clause 2: provides that 'assets' are restored as grounds for variation.

==> The draft arrears strategy also suggests the Govt intends to reintroduce this variation and the

clause addresses some of the more complex assets and how they might be calculated.

Clause 3: seeks to restore lifestyle as grounds for variation.

Clause 4: provisions to scrap the 12 month rule which allows paying parents to end court-agreed

maintenance payments after 12 months by applying to the CMS, even if their circumstances are

substantially unchanged.

==> Sections 4 and 7 of the Child Support Act 1991 allow existing consent orders to be replaced by a

statutory maintenance liability which undermines agreements made based on full disclosure of

income and assets. It was felt this should not be allowed in cases where circumstances remain

the same.

Clause 5: seeks to provide that the Secretary of State must produce a report on the effectiveness of the

Financial Investigations Unit and lay the report before both Houses within 6 months of passing the Act.

Clause 6: requires the commencement of the 2008 Child Maintenance and Other Payments Act's power

to allow disclosure to the CMS of financial information obtained in family proceedings.

==> Currently, family courts can require full disclosure of income and assets, but this can only be

made available to the CMS with the court's permission. Section 39 of the 2008 Act would allow

for this disclosure to the statutory child maintenance system without needing court permission

but it has not been brought into effect yet.

Clause 7: is consequential to Clause 1 i.e. accepting Clause 1 would make Regulation 59 (2)(b) ineffectual

so would need to be removed.

Clauses 8-10 include financial provision, definition of key terms and commencement etc.
